On March 1, 2022, the South Dakota Public Utilities Commission (Commission) received a filing from Montana-Dakota Utilities Co. (MDU) for approval of its annual update Transmission Cost Recovery (TCR) Rider. MDU states the proposed tariff change is necessary to reflect the projected 2022 charges assessed to MDU for transmission-related services provided by the Midcontinent Independent System Operator and Southwest Power Pool along with the projected revenues and/or credits received by MDU for transmission-related services. In addition, MDU is including the projected 2022 revenue requirements for three previous approved transmission projects and two new transmission projects in its projected 2022 TCR update. MDU proposes a TCR Rider rate of \$0.01734 per kWh to be effective May 1, 2022, which is an increase of \$0.01040 per kWh from that currently authorized.

On March 3, 2022, the Commission electronically transmitted notice of the filing and the intervention deadline of March 18, 2022, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listsery. No petitions to intervene or comments were filed.

The Commission has jurisdiction in this matter pursuant to SDCL 49-1A-8 and 49-34A-25.1 through 49-34A-25.4.

SDCL 49-1A-8 authorizes the Commission to require a deposit of up to \$50,000 in the Commission's Regulatory Assessment Fee Fund to defray Commission expenses incident to analyzing and ruling upon this type of filing.

At its regularly scheduled meeting on March 15, 2022, the Commission considered this matter. The Commission voted unanimously to assess a filing fee as requested by Commission staff up to the statutory limit of \$50,000 to account for actual expenses incurred in review of this filing commencing from the filing date. It is therefore

ORDERED, that MDU shall be assessed a filing fee pursuant to SDCL 49-1A-8 for actual expenses incurred by the Commission commencing from the filing date not to exceed \$50,000.
