**INTRODUCTION**

Northern States Power Company, doing business as Xcel Energy, operating in South Dakota, submits to the South Dakota Public Utilities Commission the enclosed documents, which are in accordance with Docket Nos. EL91-004 and EL14-058, for approval of our 2021 Economic Development Activities and 2022 Budget.

**B. Date of Filing and Date Modified Rates Take Effect**

Xcel Energy submits this Petition for approval on March 8, 2022. This submission has no effect on current rates.

**II. DESCRIPTION AND PURPOSE OF FILING**

The Company submits the enclosed documents for approval of our 2021 Economic Development Activities and proposed 2022 Economic Development Budget.

In 2021, none of the expended dollars were utilized for lobbying expenses for Xcel Energy or any other association that received funding during the year. All dollars that are budgeted for 2022 will similarly not be utilized for any lobbying expenses.

In 2021, there were no Governor’s Office of Economic Development (GOED), Certified Ready Site program applications thus the reason that the budgeted \$10,000 dollars were reverted back to Rural Community Support. As you will see in this year’s filing, the rural support went to the communities of Harrisburg, Alexandria, Canistota, and Centerville.

On Attachment D, pages 1 and 2, the amount invoiced and paid to Forward Sioux Falls was \$40,000, instead of the budgeted \$25,000. Only \$25,000 of our 2021 payment to Forward Sioux Falls went toward the \$100,000 budgeted in this annual filing. As with other Economic Development monies Xcel Energy spends in South Dakota, anything above the \$100,000 statutory requirement will not be paid for by rate payers.

### **III. EFFECT OF THE CHANGE UPON XCEL ENERGY REVENUE**

There is no effect on the Company’s current revenues.
