**ORDER APPROVING
TARIFF REVISIONS**

On May 19, 2022, the South Dakota Public Utilities Commission (Commission) received a filing from Black Hills Power, Inc. dba Black Hills Energy (BHE) requesting approval of revisions to its Standard Bill Forms. Specifically, BHE has proposed revisions to Section 6.00, Sheet Nos. 2, 3, 4, and 5. BHE requests an effective date of June 13, 2022.

On May 26, 2022, the Commission electronically transmitted notice of the filing and the intervention deadline of June 7, 2022, to interested entities and persons on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed.

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-34A, specifically 49-34A-4, and 49-34A-10.

At its regularly scheduled meeting on June 8, 2022, the Commission considered this matter. Commission staff recommended approval of the tariff revisions with an effective date of June 13, 2022. Finding the revisions to be just and reasonable, the Commission voted unanimously to approve the revised tariff, effective June 13, 2022. It is therefore

ORDERED, that Black Hills Energy's proposed tariff revisions are approved.
