On June 30, 2022, the South Dakota Public Utilities Commission (Commission) received a filing from MidAmerican Energy Company (MidAmerican) for approval of tariff revisions to update its Rate QF – Cogeneration and Small Power Production Facilities tariff (Rate QF). This filing updates Rate QF energy and capacity credits based on MidAmerican's current avoided costs. MidAmerican states it does not currently have any customers taking service under Rate QF. MidAmerican requests an effective date of August 15, 2022. The revised tariff sheets are as follows:

On July 7, 2022, the Commission electronically transmitted notice of the filing and the intervention deadline of July 22, 2022, to interested entities and persons on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed. On July 15, 2022, MidAmerican responded to Commission staff's data request.

The Commission has jurisdiction over this matter pursuant to 16 U.S.C Chapter 12, § 824a-3, 18 C.F.R. Part 292, SDCL Chapter 49-34A, specifically 49-34A-4, 49-34A-6, 49-34A-8, 49-34A-10, 49-34A-12, 49-34A-93, and ARSD 20:10:13:02 through 20:10:13:28.

At its regularly scheduled meeting on August 2, 2022, the Commission considered this matter. Commission staff recommended approval of the tariff revisions with an August 15, 2022, effective date. Finding the revisions to be just and reasonable, the Commission voted unanimously to approve the revisions, effective August 15, 2022.

It is therefore

ORDERED, that MidAmerican's request to revise its aforementioned tariffs is hereby granted and the revisions are approved, effective for services rendered on and after August 15, 2022.
