SUPPLEMENTAL FILING**

This Supplemental Filing reflects Otter Tail Power Company's (Otter Tail) updates in the above-captioned Docket.

**I. BACKGROUND**

Otter Tail submitted its Initial Filing in this proceeding (Petition) on June 1, 2022, requesting approval of its 2022 annual update and updated rate for the Phase-In Rider (Rider). The Petition requested approval of its 2022 Rider rate update to be effective September 1, 2022, based upon actual data through April 2022 and projected costs and collections from May 2022 through August 2023. This Supplemental Filing includes requests to approve revised tariff sheets to update rate codes and to approve an updated Customer Notice. Additionally, Otter Tail would like to update its Company contact information for this Petition.

**II. REVENUE REQUIREMENT AND RATE CALCULATION  
UPDATES**

The revenue requirement and rate calculations for both the Percent of Bill and Per Meter Charge components of the Phase-In Rider have not realized material changes since the initial June 1 filing. Otter Tail is not requesting any updates from the original request to utilize actual data through April 2022 and projected costs and collections from May 2022 through August 2023. No Rider rate updates are being requested in this Supplemental Filing.

**III. Tariffs**

Otter Tail submits redlined and clean tariff sheets in this Supplemental Filing reflecting the proposed updates described below.

While this Supplemental Filing does not request updated rates or charges, Otter Tail does request changes be made on page 1 to the Rate Codes assigned to the Per Meter Charges for each service category. These updates are necessary for consistency in the naming convention applied to our Rate Code assignments in all three of our jurisdictions for billing purposes.

Additionally, the per meter rates listed in the tariff have been revised to reflect rounding to two decimal places to illustrate the per meter charge in the standard USD format.

#### IV. CUSTOMER NOTICE

Included with this filing is an updated redline and clean version of the proposed Customer notice and rate impact. This notice was Attachment 21 to our initial filing submitted on June 1, 2022. While no changes or updates are being made to the Phase-In Rider, the new Customer Notice includes a more detailed description of the separate Rider components and a summary table of the per meter charges for each rate class.
