CONSENT AND AGREEMENT FOR EXCEPTION TO SERVICE

As Agreed To Between

Central Electric Cooperative, Inc. (Central) has assigned territorial service rights to provide electric service to the Northeast quarter (NE1/4) of the Southeast quarter (SE1/4) of Section 12, T103N, R57W, of Edgerton Township in Hanson County, South Dakota.

Central Electric agrees to allow Southeastern Electric Cooperative, Inc. (Southeastern) to supply a single phase electrical service not to exceed 50 KVA (Electrical Service) to the above described property. This consent is entered into pursuant to South Dakota Codified Law 49-34A-55.

A new home is being constructed on the property and electric utility service is required to the following described real property: Lot 3: Lot 6 NE4 SE4 Section 12 of Township One Hundred Three North (T103N), Range 57 West (R57W), Hanson County, South Dakota. The attached Exhibit A is an aerial view of the general location of said service in relation to Central's electric distribution line and Southeastern's electric distribution line.

This consent is made with the understanding and agreement that the Property remains a part of the Assigned Service Territory of Central Electric, and that by virtue of this consent, Southeastern does not acquire any service territory rights in any portion of the Property, nor will Southeastern acquire any rights to provide electric utility service on the Property or in any other area on the basis of the Electric Service allowed pursuant to this Consent. Southeastern acknowledges that Central Electric reserves the right to provide electric utility service should future installations on the property require electricity in excess of 50KVA.

This consent may not be used by Southeastern for the purpose of establishing permanent territorial service rights, nor shall it constitute or establish at any time a precedent between Central Electric and Southeastern.

Exhibit "B" provides the request of the owner of this property to have Southeastern serve this residential electric service. This release is specifically limited to the proposed residential electric service and is for the life of said service.

This consent is not to be construed as having any impact upon or indicating a desire to change the service areas assigned by the South Dakota Public Utilities Commission.

This agreement becomes effective upon its approval by the South Dakota Public Utilities Commission.
