Re: Local Balancing Authority Agreement Between Interstate Power and Light Company as the Alliant West Local Balancing Authority and Chickasaw Wind Energy Center LLC

Dear Secretary Bose:

Pursuant to Section 205 of the Federal Power Act¹ and Part 35.13 of the Federal Energy Regulatory Commission’s (“FERC” or “Commission”) rules and regulations,² MidAmerican Energy Company (“MidAmerican” or “MEC”) respectfully submits a Certificate of Concurrence and a concurrence tariff record for MidAmerican’s (MEC Transmission) eTariff database to reflect its incorporation by reference of the Remote Local Balancing Authority Generator Interchange Agreement (“RLBAA”) Between Interstate Power and Light Company (“IPL”) and Chickasaw Wind Energy Center LLC (“Chickasaw”), MEC’s predecessor in interest, filed by IPL on July 7, 2023 in Docket No. ER23-2352.

I. Description of Filing

On July 7, 2023, Alliant Energy Corporate Services, Inc., on behalf of IPL filed in the above-referenced docket the RLBAA between IPL and Chickasaw.³ IPL requested the RLBAA become effective September 6, 2023.⁴

Paragraph 7 of the RLBAA contemplates the assignment of Chickasaw’s interest in the RLBAA to MidAmerican. Because the RLBAA anticipated assignment to MidAmerican, no changes to the RLBAA are necessary for Commission approval. MidAmerican is submitting a concurrence tariff record to incorporate the agreement into MidAmerican’s eTariff database and a Certificate of Concurrence with respect to the rate schedule.
