On February 13, 2024, the South Dakota Public Utilities Commission (Commission) received a Petition from Otter Tail Power Company (Otter Tail) for approval of a new My Renewable Energy Credits (My RECs) voluntary rider. This rider will allow nonresidential customers with a maximum demand of at least 20 kW to offset carbon associated with their energy use with Otter Tail's excess generated Renewable Energy Credits (RECs). RECs will be retired on the subscriber's behalf annually. The annual participation cap for this rider will initially be 600,000 MWh.

On February 15, 2024, the Commission electronically transmitted notice of the filing and the intervention deadline of March 1, 2024, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed. On March 13, 2023, Otter Tail filed responses to Staff's data request. On May 3, 2024, Otter Tail filed Revised Tariff Pages.

The Commission has jurisdiction in this matter pursuant to SDCL Chapter 49-34A, specifically 49-34A-4 and 49-34A-10, and ARSD Chapter 20:10:13.

At its regularly scheduled meeting on May 8, 2024, the Commission considered this matter. Commission Staff recommended approval of the tariff revisions. Finding the revisions to be just and reasonable, the Commission voted unanimously to approve the revisions effective June 1, 2024. It is therefore

ORDERED, that Otter Tail's request to revise its aforementioned tariff sheets is hereby granted, and the revision are approved, effective for services rendered on and after June 1, 2024.
