

**NOTICE OF LIMITED CONSTRUCTION**

July 16, 2025

**RE:** In the Matter of the Application by Deuel Harvest Wind Energy South LLC for Energy Facility Permits of a Wind Energy Facility and a 345-kV Transmission Facility in Deuel County, South Dakota, Docket No. EL24-023

Deuel County Landowner:

You are receiving this notice because you own property within the South Deuel Wind project area or within one-half mile outside of the project area. Deuel Harvest Wind Energy South LLC plans to undertake limited construction for the South Deuel Wind Project. The scope of this limited construction includes the excavation for and installation of two mud mats for turbine numbers 37 and 38 located in the S1/2 of Section 23, Township 114N, Range 49W, Deuel County, South Dakota. The extent of this work will be limited to this location.

A mud mat is thin concrete that is installed at the base of a turbine location after excavation of the dirt, and provides a clean surface below grade for the future installation of a turbine foundation. The areas for turbine numbers 37 and 38 will be excavated and concrete will be poured. Upon curing, the mud mats will be back filled leaving a slight mound. Construction and installation of turbine towers and turbine foundations are not part of this first phase of construction.

Access for this limited construction will exclusively use state roads and the project team is coordinating with the South Dakota Department of Transportation.

This limited construction is anticipated to begin on August 4, 2025 and take approximately two to three weeks to complete.

Included with this notice as **Attachment A**, is the project construction/maintenance damage compensation plan and procedure. If you are not the owner of the property where this limited construction is located, the use of this is not applicable. However, it's being provided for your benefit and general awareness of this process.
