On June 28, 2024, the South Dakota Public Utilities Commission (Commission) received a Petition of Dakota Renewable Hydrogen, LLC to have Kingsbury Electric Cooperative, Inc. assigned as its electric provider in the service area of Otter Tail Power Company (Petition). The Petition asks the Commission for an order pursuant to SDCL 49-34A-56 that allows DRH to take electric service from Kingsbury Electric Cooperative, Inc. for its proposed hydrogen production facility to be located adjacent to, and as part of, Gevo Inc.'s proposed ethanol and sustainable aviation fuel (SAF) facility east of Lake Preston, South Dakota, that is currently within the assigned service area of Otter Tail Power Company. Under SDCL 49-34A-56, new customers at new locations that develop after March 21, 1975, and who require electric service with a contracted minimum demand of two thousand kilowatts or more are not obligated to take electric service from the electric utility having the assigned service area where the customer is located if the Commission so determines after consideration of certain factors set forth in statute.

On July 3, 2024, the Commission electronically transmitted notice of the filing and the intervention deadline of July 19, 2024, to interested individuals and entities on the Commission's PUC Weekly Filing electronic listserv. On August 1, 2024, the Commission issued an Order Granting Intervention to Kingsbury Electric Cooperative, Inc.; East River Electric Cooperative, Inc.; and Otter Tail Power Company. On October 1, 2024, staff filed a Motion for Procedural Schedule.

The Commission has jurisdiction in this matter pursuant to SDCL Chapter 1-26 and SDCL 49-34A-56 and ARSD Chapter 20:10:01.

At its regularly scheduled meeting on October 8, 2024, the Commission considered this matter. No party objected to the schedule suggested by Staff in its Motion. The Commission voted unanimously to grant Staff's Motion for Procedural Schedule filed on October 1, 2024. In addition, the Commission found that pursuant to SDCL 15-6-42(a) that no party would be prejudiced by consolidating Docket Nos. EL24-024 and EL24-025 for an evidentiary hearing and that consolidation was appropriate based upon the facts and the laws at issue. It is therefore

ORDERED, that the Motion for Procedural Schedule is granted. It is further

ORDERED, that the Procedural schedule is established as follows:


ORDERED, that this docket shall be consolidated with EL24-024 pursuant to SDCL 15-6-42(a) for evidentiary hearing. It is further

ORDERED, that responses to discovery are due seven business days after service of discovery except as provided in the procedural schedule above. It is further


