

COME NOW FEM Electric Association, Inc. (“FEM”), East River Electric Power Cooperative, Inc. (“East River”), and Basin Electric Power Cooperative (“Basin Electric”) (collectively, the “Intervenors”), by and through their counsel of record, and jointly request the following relief against each of Leola Data Center LLC and Montana Dakota Utilities Co.:


1. FOR AN ORDER, pursuant to SDCL §§ 15-6-37(a)(2) and 15-6-37(a)(3), compelling Leola Data Center LLC to provide full and complete responses to the following:
 - a. Interrogatory No. 21 and Request for Production No. 4 of Intervenors’ October 4, 2024, discovery requests, and
 - b. Request Nos. 1-1, 1-4, 1-5, 1-6, and 1-13 of Intervenors’ December 11, 2024, discovery requests.

2. FOR AN ORDER, pursuant to SDCL §§ 15-6-37(a)(2) and 15-6-37(a)(3), compelling Montana Dakota Utilities Co. to provide full and complete responses to Intervenors’ December 3, 2024, discovery requests to Montana Dakota Utilities Co., specifically Request 1-1.


