ORDER APPROVING TARIFF REVISIONS

On October 21, 2024, the South Dakota Public Utilities Commission (Commission) received a filing from Montana-Dakota Utilities Co. (MDU) for approval of revisions to its Rate 95 (occasional power purchase nontime differentiated) and Rate 96 (short-term power purchase) tariff sheets. This filing updates the energy and capacity payments based on current data. MDU states it currently has one customer taking service under Rate 95 and the annual change in revenue due to this filing will be minimal. MDU requests a January 1, 2025, effective date.

The revised tariff sheets are as follows:

On October 24, 2024, the Commission electronically transmitted notice of the filing and the intervention deadline of November 8, 2024, to interested entities and persons on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed. On November 21, 2024, MDU responded to staff's data request.

The Commission has jurisdiction over this matter pursuant to 16 U.S.C. Chapter 12, § 824a-3, 18 C.F.R. Part 292, SDCL Chapter 49-34A, specifically 49-34A-4, 49-34A-6, 49-34A-8, 49-34A-10, 49-34A-12, and 49-34A-93, and ARSD 20:10:13:02 through 20:10:13:28 and 20:10:13:39.

On December 3, 2024, at its regularly scheduled meeting, the Commission considered this matter. Commission staff recommended approval of the tariff revisions with a January 1, 2025, effective date. Finding the revisions to be just and reasonable, the Commission voted unanimously to approve the revisions. effective January 1, 2025.

It is therefore

ORDERED, that MDU's request to revise its above-mentioned tariffs is hereby granted and the revisions are approved, effective for services rendered on and after January 1, 2025.
