Northern States Power Company, a Minnesota corporation submits to the South Dakota Public Utilities Commission this compliance report regarding the credit to South Dakota retail electric customers resulting from the sixth settlement payment received from the U.S. Department of Energy for failure to take the Company's spent nuclear fuel. We submit this report in compliance with the Commission's February 17, 2016 ORDER in the above-referenced Docket.

CREDIT SUMMARY

In compliance with the Commission's Order we began posting bill credits from the sixth DOE settlement payment to our electric customers on April 11, 2016 with all credits applied to customer accounts as of May 10, 2016. Including interest accrued since receipt of payment on November 5, 2015, a total of \$676,761 was credited to South Dakota retail electric customers.

As summarized in Attachment A to this filing, the total amount credited included \$675,451 for the South Dakota jurisdictional retail portion, plus interest of \$430 (less \$58 in bank fees), resulting in a total calculated bill credit of \$675,823. The amount actually credited to customers was \$676,761 as shown in Attachment B to

this filing. We provide the detail of our interest and bank fees calculation in Attachment C to this filing.

Please note, in preparing this report we discovered a clerical error while entering amounts used in calculating the credit refund factor to the customer bill credits. The sixth settlement amount for South Dakota shown on line 1 of Attachment A should have been \$685,514 instead of the \$675,451. This resulted in an under credit amount totaling \$9,125.

This error was discovered after the bill credit implementation process was already under way and given the relatively small amount per customer, we will carry the \$9,125 credit, plus interest, forward to be included in with the next (seventh) DOE Settlement payment bill credits, which we expect to receive in fourth quarter 2016. The derivation of the credit amount carried to the seventh DOE Settlement Payment is shown below.
