These rates are for small qualifying facilities within the Otter Tail service area. Otter Tail requests an effective date of April 1, 2024.

At its regularly scheduled meeting on March 26, 2024, the Commission considered this matter. Commission staff recommended approval of the tariff revisions with an April 1, 2024, effective date. Finding the revisions to be just and reasonable, the Commission voted unanimously to approve the revisions, effective April 1, 2024. It is therefore

ORDERED, that Otter Tail's request to revise its aforementioned tariff sheets is hereby granted, and the revisions are approved, effective for services rendered on and after April 1, 2024.
