ORDER APPROVING TRANSMISSION COST RECOVERY RIDER RATE AND TARIFF REVISION

EL24-007

On March 1, 2024, the South Dakota Public Utilities Commission (Commission) received a filing from Montana-Dakota Utilities Co. (MDU) for approval of its annual update to the Transmission Cost Recovery (TCR) Rider. MDU states the proposed tariff change is necessary to reflect the projected 2024 charges assessed to MDU for transmission-related services provided by the Midcontinent Independent System Operator and Southwest Power Pool, along with the projected revenues and/or credits received by MDU for transmission-related services, including transmission revenues from a large customer taking service under MDU's Rate 45 tariff. MDU proposes a TCR Rider rate of negative \$0.00216 per kWh to be effective May 1, 2024, which is a decrease of \$0.00586 per kWh from current interim rates and a decrease of \$0.01848 from the rate authorized in the last TCR filing.

On March 7, 2024, the Commission electronically transmitted notice of the filing and the intervention deadline of March 22, 2024, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed. On April 17, 2024, Commission staff filed its memorandum in this matter.

The revised tariff sheet effective for service rendered on and after May 1, 2024, is as follows:

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-34A, specifically 49-34A-4, 49-34A-6, 49-34A-8, 49-34A-10, 49-34A-12, and 49-34A-25.1 through 49-34A-25.4, and ARSD Chapter 20:10:13.

At its regularly scheduled meeting on April 23, 2024, the Commission considered this matter. Commission staff recommended approval, as outlined in its memorandum, of the revised TCR Rider rate of negative \$0.00216 per kWh and the revised tariff sheet. Finding the revisions to be just and reasonable, the Commission voted unanimously to approve the revised TCR Rider rate and revised tariff sheet, effective May 1, 2024. It is therefore

ORDERED, that the revised TCR Rider rate of negative \$0.00216 per kWh and the above-referenced tariff sheet are hereby approved, effective May 1, 2024.
