NOTICE OF PUBLIC MEETING SOUTH DAKOTA PUBLIC UTILITIES COMMISSION

WHAT: Permit for East River Electric Power Cooperative, Inc. to Construct a 230kV transmission line from WAPA North Bend Substation to Pratt Substation in Sections 15/16, T110N, R73W, Hyde County, South Dakota

WHEN AND WHERE: Wednesday, May 8, 2024, at 5:30 p.m., CDT, in Room 413 of the State Capitol Building, 500 E. Capitol Ave., Pierre, South Dakota

Pursuant to SDCL Chapter 49-41B, the South Dakota Public Utilities Commission (Commission) will hold a public input meeting at the above time and place on an application to construct a 500-foot 230 kV transmission line and associated facilities (Project) in Sections 15 and 16 of T110N, R73W, Hyde County, SD. The Project will connect the North Bend Substation owned by the Western Area Power Administration (WAPA) with the Pratt Substation owned by East River. The Project will be located on land owned by WAPA or East River, with the exception of the crossing of the public road Right of Way for County Road 649.

The purpose of the public input hearing will be to hear public comments regarding the Application and the Project. At the hearing, East River will present a brief description of the Project, after which interested persons may appear and present their views, comments, and questions regarding the Application. A copy of the Application is on file with the Hyde County Auditor and at the Commission's office in Pierre. The Application and all other documents in the docket, including detailed maps of the Project, may be accessed on the Commission's web site at <u>puc.sd.gov</u> under Commission Actions, Commission Dockets, Electric Dockets, 2024 Electric Dockets, EL24-011 or by contacting the Commission in person at the Capitol Building, 500 E. Capitol Ave., Pierre, SD, or by phone at (605) 773-3201.

Pursuant to SDCL 49-41B-17 and ARSD 20:10:22:40, the parties to this proceeding are currently the Applicant and the Commission Staff. Each municipality, county, and governmental agency in the area where the facility is proposed to be sited; or any person residing in the area where the facility is proposed to be sited, or any directly interested person, may be granted party status in this proceeding by making timely written application to the Commission. Applications for party status will be available at the public input hearing or may be obtained from the Commission's web site or by contacting the Commission. Applications for party status must be filed with the Commission on or before 5:00 p.m., CDT, May 21, 2024. The Commission will also accept comments in writing from anyone, either by mail, personal delivery, or e-mail until the time of the decision. You only need to apply for party status if you want to participate formally in the case by putting on actual testimony or other factual evidence, conducting discovery, cross-examining witnesses, making legal arguments, and to preserve your right to appeal to the courts if you do not believe the Commission's decision is legally correct. You do not need to have party status in order to submit written comments.

Following the public input meeting, the Commission may schedule a formal evidentiary hearing conforming to SDCL Chapter 1-26 to consider issues raised by any party or the Commission itself. At such a formal hearing, all parties will have the opportunity to appear, present evidence, and

cross-examine the other parties' witnesses and exercise all other rights afforded by SDCL Chapters 1-26, 49-1, and 49-41B and ARSD Chapters 20:10:01 and 20:10:22, including rights of appeal to the courts.
