MidAmerican Energy Company (MidAmerican) hereby submits the Revised Transmission Cost Recovery (TCR) reconciliation for 2024 and the calculation of the 2025 TCR factors, in accordance with the Settlement Stipulation in Docket No. EL14-072. The new TCR factors will be effective with the first April 2025 bill groups through the final March 2026 bill groups.

Pg 6-Actual O-U by Rev Class tab was revised to transpose the amounts on line 6 columns (b-m) with line 11 columns (b-m). Amounts shown on Page 4 line 1, columns c-l were also revised from the 2024 Forecast to the 2025 Forecast. Updated proposed factors and tariffs are included in this filing.

Pursuant to S.D. Admin. R. 20:10:01:39 et seq., MidAmerican respectfully requests confidential treatment of the file 2025 Plan ElectricityForecasts_Confidential, MEC_AttGG_010125-0123125_SD ROE_Confidential, MEC_AttMM_010125-0123125_SD ROE_Confidential, and MEC_AttO_010125-0123125_SD ROE_Confidential. MidAmerican respectfully requests that 2025 Plan ElectricityForecasts_Confidential, MEC_AttGG_010125-0123125_SD ROE_Confidential, MEC_AttGG_010125-0123125_SD ROE_Confidential, and MEC_AttO_010125-0123125_SD ROE_Confidential should be accorded confidential treatment for three years or such time as the Commission may deem reasonable.

The confidential materials constitute a trade secret and, if released, would give an advantage to competitors and serve no public purpose. The confidential material contains commercially sensitive information, which if released to the general public, would give an unfair advantage to existing and potential electric suppliers and customers. *Food Marketing Institute v. Argus Leader Media*, 139 S. Ct. 2356, 2358 (2019).

Included with this filing is a revised Application for approval of its Revised 2024 Transmission Cost Recovery Reconciliation and 2025 New Factor Calculation. MidAmerican is also filing revised proposed customer notices for rates GE and GD that will be mailed to each affected customer with the first bill for service under the proposed rates.
