On February 28, 2025, the South Dakota Public Utilities Commission (Commission) received a filing from Montana-Dakota Utilities Co. (MDU) for approval of its annual update to its Transmission Cost Recovery (TCR) Rider. MDU states the proposed tariff change is necessary to reflect the projected 2025 charges assessed to MDU for transmission-related services provided by the Midcontinent Independent System Operator and Southwest Power Pool, along with the projected revenues and/or credits received by MDU for transmission-related services, including transmission revenues from a large customer taking service under MDU's Rate 45 tariff. MDU proposes a TCR Rider rate of negative \$0.00127 per kWh to be effective May 1, 2025, which is an increase of \$0.00089 per kWh from current rate authorized in the last TCR filing.

On March 6, 2025, the Commission electronically transmitted notice of the filing and the intervention deadline of March 21, 2025, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listsery. No petitions to intervene or comments have been filed to date.

The Commission has jurisdiction in this matter pursuant to SDCL 49-1A-8 and 49-34A-25.1 through 49-34A-25.4.

SDCL 49-1A-8 authorizes the Commission to require a deposit of up to \$50,000 in the Commission's Regulatory Assessment Fee Fund to defray Commission expenses incident to analyzing and ruling upon this type of filing.

At its regularly scheduled meeting on March 11, 2025, the Commission considered this matter. The Commission voted unanimously to assess a filing fee as requested by Commission staff up to the statutory limit of \$50,000 to account for actual expenses incurred in review of this filing commencing from the filing date. It is therefore

ORDERED, that MDU shall be assessed a filing fee pursuant to SDCL 49-1A-8 for actual expenses incurred by the Commission commencing from the filing date not to exceed \$50,000.
