**ORDER ASSESSING  
FILING FEE**

**EL25-007**

On February 28, 2025, the South Dakota Public Utilities Commission (Commission) received a Petition by Montana-Dakota Utilities Co. (MDU) for approval of its annual update to its Infrastructure Rider (IR) Rate, pursuant to the terms of the MDU's IR Rate 56 tariff. MDU proposes an IR rate of \$0.00260 per kWh for the rate period covered by this filing, which is a decrease of \$0.00134 per kWh from the rate authorized in the last IR filing. The IR Rate 56 tariff requires MDU to update the IR annually with updates effective May 1 of each year.

On March 6, 2025, the Commission electronically transmitted notice of the filing and the intervention deadline of March 21, 2025, to interested persons and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments have been filed to date.

The Commission has jurisdiction over this matter pursuant to SDCL 49-34A-73 through 49-34A-78. SDCL 49-34A-77 authorizes the Commission to require a deposit of up to \$250,000 in the Commission's Regulatory Assessment Fee Fund to defray Commission expenses incident to analyzing and ruling upon this type of filing.

At its regularly scheduled meeting on March 11, 2025, the Commission considered this matter. Commission staff requested that the Commission assess a filing fee not to exceed \$250,000 to account for actual expenses incurred in review of this filing. The Commission voted unanimously to assess MDU a filing fee in an amount not to exceed \$250,000 to account for actual expenses incurred in review of this filing commencing from the filing date. It is therefore

ORDERED, that MDU shall be assessed a filing fee pursuant to SDCL 49-34A-77 for actual expenses incurred by the Commission commencing from the filing date not to exceed \$250,000.
