DSM COST ADJUSTMENT FACTOR DECREASE EFFECTIVE JANUARY 1, 2026

Xcel Energy offers a variety of load management and demand side management (DSM) programs to our South Dakota customers to help them reduce their home's usage. The South Dakota Public Utilities Commission has approved a new Demand Side Management Cost Adjustment Factor as a separate line item on your monthly electric bill to recover the cost of our load management and DSM programs. The DSM cost adjustment factor will decrease from \$0.000452 per kWh to \$0.000427 per kWh beginning January 1, 2026.

RESIDENTIAL ELECTRIC SERVICE — AVERAGE BILL EXAMPLE

This chart provides a comparison of customer bills by applying the prior DSM rate versus the new DSM rate. The table below shows the DSM Rider rate decrease only and does not factor in any other rate change that may occur at the same time.
