
The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-34A, including 49-34A-1, 49-34A-2, 49-34A-3, 49-34A-4, 49-34A-6, 49-34A-8, 49-34A-8.3, 49-34A-8.4, 49-34A-10 through 49-34A-14, 49-34A-17, 49-34A-19 through 49-34A-19.2, 49-34A-21, 49-34A-22, and applicable provisions of SDCL Chapters 1-26 and 15-6.

At its regularly scheduled meeting on March 10, 2026, the Commission considered this matter. The Commission heard from Otter Tail and Commission staff concerning the Joint Motion and Settlement Stipulation. Having thoroughly reviewed the filings in the docket and after having made further extensive inquiry of the parties, the Commission found that the terms and conditions proposed in the Settlement Stipulation were just, reasonable, and in the public interest and that good and sufficient cause was demonstrated to approve the Settlement Stipulation. The Commission voted unanimously to grant the Joint Motion for Approval of Settlement Stipulation and to approve the Settlement Stipulation, including the attached Interim Rate Refund Plan. It is therefore

ORDERED, that the Joint Motion for Approval of Settlement Stipulation is hereby granted and the Settlement Stipulation, including the attached Interim Rate Refund Plan, is approved. The Settlement Stipulation is incorporated by reference into this Decision and Order the same as if it had been set forth in its entirety herein. It is further

ORDERED, that the aforementioned tariff sheets are approved for service rendered on and after April 1, 2026.
