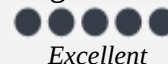

Forecasting Process and System Implementation (2016-2017)

- Created vision and goal for a new forecasting system to be implemented across the utility to provide more accurate and timely information to the Board, executive team, and the organization
- Moved from annual budgeting and monthly close reporting to a dynamic monthly forecast for the current year and a longer 5-year planning period
- Oversight of project planning and implementation timeline development including software integration and testing, employee training and development, process development and mapping, and reporting structure and development
- Responsible for execution of project, training of several hundred managers and analysts and incorporation of the forecast into the enterprise financial model
- Additional implementation of new sales/load forecasting system (Itron) to stabilize revenue projections for all four utility services

Debt Portfolio Stabilization (continuous)

- Developed strategies to reduce risk and proactively manage an existing debt portfolio of over \$2 billion including fixed, variable and swap debt structures
- Diversified swap counterparty exposures using a planned execution of marketing and relationship building with key global banks
- Created plan approved by Board and executive team to capitalize on opportunities to terminate swap agreements
- Analyze and execute refunding opportunities for existing fixed rate debt, generating savings of over \$100 million in interest expense for the Utility
- Moved credit rating from a low AA position to a high AA with Moody's and a AA+ with S&P
- Maintain strong relationships with rating agencies, key banks, financial advisor, and bond/tax attorneys

Rate Modernization and Coordination (currently in progress)

- Developed long term plan to review rate structure efficiency in all four utility services beginning with electric rates while utilizing expertise from external consultants
- Led the Board through a half-day workshop, providing insight to the process, reasons for the project and how governance fits into our overall rate strategy
- Strategically changed existing tariffs for Small Power Producers and Net Metering (residential) to position Utilities for larger changes in the future
- Created a certified Green Power Rate for businesses and residential customers who need or want qualified renewable certifications
- Working with internal and external parties on developing pilot rates and strategies for small scale distributed generation/storage and electric vehicle charging
