REQUEST FOR CONFIDENTIAL TREATMENT OF INFORMATION

Otter Tail Power Company (Otter Tail) requests the South Dakota Public Utilities Commission (Commission) to approve confidential treatment for the below-identified information pursuant to Administrative Rules of South Dakota (ARSD) § 20:10:01:41.

1. Otter Tail requests confidential protection and treatment of the confidential portion of the petition. The information is marked "CONFIDENTIAL – CONTAINS TRADE SECRET DATA."
2. The document must be protected for the life of this Docket. When the Docket is closed, all protected information must be returned to Otter Tail.

4. The claim for protection is based on ARSD § 20:10:01:39 (4) and SDCL § 37-29-1 (4). The information contained within the confidential portions of this report meets the definition of "trade secret" under the SDCL § 37-29-1(4), the South Dakota Uniform Trade Secret Act, which defines the term as information that "[d]erives independent economic value, actual or potential, from not being generally known to, and not being readily ascertainable by proper means by, other persons who can obtain economic value from its disclosure or use; and is the subject of efforts that are reasonable under the circumstances to maintain its secrecy." In addition, Section 1.09 of the Company's South Dakota Rules and

Regulations protects from public disclosure customer electric usage, payments, and related meter data, whether actual or projected.

5. Otter Tail seeks confidential treatment of Attachment 1 to SD-PUC-01.01, which is a confidential Electric Service Agreement between the Company and Valley Queen Cheese Factory, Inc. that contains terms specific to the customer. Otter Tail also seeks confidential treatment of designated portions of SD-PUC-01.03 and SD-PUC-01.04 which contain customer specific billing, revenue and usage information. The Company is obligated to maintain the confidentiality of this information and not disclose this information to the public. Accordingly, Otter Tail respectfully requests that the Commission authorize confidential protection and treatment of this information.

The information for which confidential treatment is requested has been marked "CONFIDENTIAL – CONTAINS TRADE SECRET DATA" and is being transmitted electronically as a separate document.
