**ORDER APPROVING  
TARIFF REVISIONS**

On December 1, 2025, the South Dakota Public Utilities Commission (Commission) received a filing from MidAmerican Energy Company (MidAmerican) for approval of tariff revisions regarding bill payment options. MidAmerican requests the tariff revisions have an effective date of January 1, 2026. Beginning on this date, customers who wish to pay by phone will do so exclusively through MidAmerican's secure automated phone system.

On December 4, 2025, the Commission electronically transmitted notice of the filing, to interested entities and persons on the Commission's PUC Weekly Filings electronic listserv. On December 11, 2025, the Commission electronically transmitted a second notice of the filing and the revised intervention deadline of December 15, 2025, to interested entities and persons on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed.



The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-34A, specifically 49-34A-4 and 49-34A-10, and ARSD Chapter 20:10:13.

At its regularly scheduled meeting on December 16, 2025, the Commission considered this matter. Commission staff recommended approval of the tariff revisions, effective January 1, 2026. Finding the revisions to be just and reasonable, the Commission, with Commissioner Fiegen dissenting, voted to approve the revisions, effective January 1, 2026. It is therefore

ORDERED, that MidAmerican's request to revise its aforementioned tariff is hereby granted and the revisions are approved, effective for services rendered on and after January 1, 2026.
