2. THENCE continue south to the NW corner of Lot C of Nelson Tract 1 of the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 29 of T91N, R49W,
3. THENCE continue east to the NE corner of Lot C of Nelson Tract 1 of the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 29 of T91N, R49W,
4. THENCE continue south and west following the boundary of Lot C of Nelson Tract 1 to the SW corner of Lot C of Nelson Tract 1 of the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 29 of T91N, R49W,
5. THENCE continue south to the NW corner of Lot G of Section 29 of T91N, R49W,
6. THENCE continue southeast following the boundary of Lot G to the SE corner of Lot G of Section 29 of T91N, R49W,
7. THENCE continue west following the south Boundary of Lot G to Interstate 29 in Section 29 of T91N, R49W,
8. THENCE continue northwest following Interstate 29 to a point of intersection with the centerline of the Burlington Northern Santa Fe Railroad in Section 13 of T91N, R50W,
9. THENCE continue southeast along the centerline of the Burlington Northern Santa Fe Railroad to the east boundary of Section 24 of T91N, R50W,
10. THENCE continue north to the centerline of SD Highway 11 on the west boundary of Section 19 of T91N, R49W,
11. THENCE continue southeast along the centerline of SD Highway 11 to the west corner of Lot X of Section 19 of T91N, R49W,
12. THENCE continue northeast to the north corner of Lot X of Section 19 of T91N, R49W,

13. THENCE continue southeast to the east corner of Lot X of Section 19 of T91N, R49W,
14. THENCE continue northeast to the north corner of Curry Tract 1 of Section 19 of T91N, R49W,
15. THENCE continue south to the south line of the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 19 of T91N, R49W,
16. THENCE continue east to a line extending northwest from the centerline of Sioux Street of Section 19 of T91N, R49W,
17. THENCE continue southeast along the centerline of Sioux Street to the NW corner of Fennel Tract 1 of Section 19 of T91N, R49W,
18. THENCE continue east to the NE corner of Fennel Tract 1 of Section 19 of T91N, R49W,
19. THENCE continue south to the SE corner of Fennel Tract 1 of Section 19 of T91N, R49W,
20. THENCE continue west to the SW corner of Fennel Tract 1 of Section 19 of T91N, R49W,

28. THENCE continue northwest along the southwest boundary of Hoffman Tract 3 of Lot M and continue along the line extending NW to the intersection with the west boundary of the SW $\frac{1}{4}$ of Section 19 of T91N, R49W,
29. THENCE continue south to the SE corner of Lot B of Government Lot 1 of Section 19 of T91N, R49W,
30. THENCE continue west to the midpoint of the south boundary of the Cemetery in Section 19 of T91N, R49W,
31. THENCE continue south to the south boundary of the N $\frac{1}{2}$ of the NW $\frac{1}{4}$ of Section 30 of T91N, R49W,
32. THENCE continue east to the intersection of the NW boundary of Lot 48, Block 4, Country Club Estates in Section 30 of T91N, R49W,
33. THENCE continue northeast to the north corner of Lot 48, Block 4, Country Club Estates in Section 30 of T91N, R49W,
34. THENCE continue southeast along the boundary of Lot 48, Block 4, Country Club Estates to the centerline of Arnold Palmer Ln in Section 30 of T91N, R49W,
35. THENCE continue east along Arnold Palmer Ln to the intersection with the line extending NW from the SW boundary of Lot 18, Block 9, Country Club Estates in Section 30 of T91N, R49W,
36. THENCE continue SE along the line extending NW from the SW boundary of Lot 18, Block 9, Country Club Estates to the south corner of Lot 18, Block 9, Country Club Estates in Section 30 of T91N, R49W,
37. THENCE continue NE along the SE boundary of Lot 18, Block 9, Country Club Estates to the south boundary of the N $\frac{1}{2}$ of the NE $\frac{1}{4}$ of Section 30 of T91N, R49W,
