Southeastern Electric Cooperative, Inc. (Southeastern) has assigned territorial service rights to provide electric service to the Southwest quarter (SW¼) of the Northwest quarter (NW¼) of Section 30, T100N, R061W, of Starr Township in Hutchinson County, South Dakota.

Under the conditions of this agreement, Southeastern does hereby consent that Douglas Electric Cooperative, Inc. (Douglas) may extend its facilities into the above-described service area of Southeastern to provide electric service requested by Craig Bialas, 40407 271st Street, Parkston, SD 57366, cell 605-505-0142.

Craig Bialas's letter is attached and explains his request to have Douglas serve this single phase, residential electric service in Section 30 described above. Exhibit "B" provides a map of the general location of said service in relations to Douglas' electric distribution line and Southeastern. This release is specifically limited to the proposed new, single phase, residential electric service and is for the life of said service.

This consent is not to be construed as having any impact upon or indicating a desire to change the service areas assigned by the South Dakota Public Utilities Commission. This agreement becomes effective upon its approval by the South Dakota Public Utilities Commission.

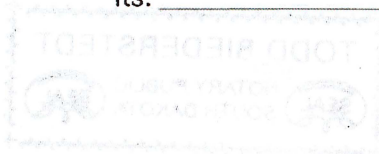

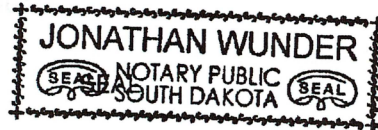
