On February 13, 2026, the South Dakota Public Utilities Commission (Commission) received MidAmerican Energy Company's (MidAmerican) filing for approval of tariff revisions regarding its Transmission Cost Recovery (TCR) 2025 Reconciliation and 2026 New Factor Calculation. MidAmerican's TCR mechanism was established in the company's most recent rate case, EL14-072. With this filing, MidAmerican is establishing new TCR rates based on true ups to the actual over/under recovery from 2025, 2026 forecasted Midcontinent Independent System Operator transmission expense, and the forecasted over/under recovery for January through March of 2026. MidAmerican requests the new TCR factors have an effective date of April 2, 2026.

On February 19, 2026, the Commission electronically transmitted notice of the filing and the intervention deadline of March 6, 2026, to interested entities and persons on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed. On March 18, 2026, MidAmerican filed workpapers.

The revised tariff sheet, effective for service rendered on or after April 2, 2026, is as follows:

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-34A, specifically 49-34A-4, 49-34A-6, 49-34A-8, 49-34A-10, 49-34A-12, and 49-34A-25.1 through SDCL 49-34A-25.4, and ARSD 20:10:13.

At its regularly scheduled meeting on March 26, 2026, the Commission considered this matter. Commission staff recommended approval of the revised TCR rate factors and revised tariff sheet with an effective date of April 2, 2026. Having thoroughly reviewed the filings in the docket, the Commission found the TCR rates and tariff revisions to be just and reasonable. The Commission voted unanimously to approve the revised TCR rate factors and revised tariff sheet with an effective date of April 2, 2026. It is therefore

ORDERED, that the revised TCR rate factors and revised tariff sheet set forth above are approved effective April 2, 2026.
