

EXCEPTION TO ASSIGNED SERVICE AREA

Central Electric Cooperative, Inc. ("Central") is the assigned electric service provider, with the exclusive territorial right to provide retail electric service, for the Northeast Quarter (NE $\frac{1}{4}$) of Section 36, T102N, R057W, Hanson County, South Dakota (the "Service Area").

Subject to the terms and conditions of this Agreement and approval by the South Dakota Public Utilities Commission (the "Commission"), Central hereby consents to Southeastern Electric Cooperative, Inc. ("Southeastern") extending its facilities into the Service Area solely to provide the electric service requested by Trent Wollman ("Customer") at the parcel identified as the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$, North and East of Railroad ROW, of Section 36, T102N, R057W. In the future, this parcel will also be described as xxxxx 430th Ave, Emery, SD 57332 when a 911 address is assigned.

Customer's written request is attached hereto as Exhibit C and incorporated by reference. Exhibit A depicts the general location of the requested service in relation to Central's and Southeastern's existing distribution facilities and Exhibit B more specifically identifies the specific parcel. The consent granted herein is a limited, one-time exception applicable only to the proposed new three-phase electric service at the location described above and shall not be construed as a general release of Central's territorial rights with respect to any other premises, load, or service within the Service Area. Central expressly reserves the right, in its sole discretion, to provide three-phase service to Customer at such location in the future in the event Central extends three-phase facilities to such location for other purposes and at no cost to Customer. If Central thereafter elects to assume provision of such three-phase service to Customer at such location, Central shall reimburse Southeastern for the undepreciated cost of Southeastern's facilities reasonably and necessarily installed to serve such location, less any contributions in aid of construction paid by Customer toward such facilities.

Nothing in this Agreement shall be construed to amend, modify, waive, or otherwise affect the electric service territories assigned by the Commission, nor to evidence any intent by either party to seek a change in such assigned territories. This Agreement shall become effective only upon the Commission approval.

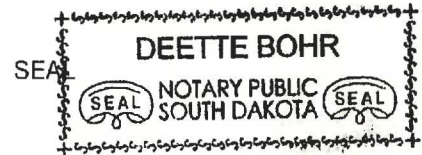
