On January 19, 2024, the South Dakota Public Utilities Commission (Commission) received a filing from NorthWestern Energy Public Service Corporation dba NorthWestern Energy (NorthWestern) requesting to revise sample forms tariff sheets to reflect language approved by the Commission in Docket No. EL23-016 and Docket NG23-001. NorthWestern requests an effective date of March 1, 2024.

On January 25, 2024, the Commission electronically transmitted notice of the filing and the intervention deadline of February 9, 2024, to interested individuals and entities on the Commission’s PUC Weekly Filings electronic listserv. No petitions to intervene or comments were received.

At its regularly scheduled meeting on February 20, 2024, the Commission considered this matter. Commission staff recommended approval of the tariff revisions with a March 1, 2024, effective date. Finding the revisions to be just and reasonable, the Commission voted unanimously to approve the revisions, effective March 1, 2024. It is therefore

ORDERED, that Northwestern’s request to revise the above-referenced tariffs is hereby granted and the revisions are approved, effective for services rendered on and after March 1,

2024.
