The only paperwork I was given were the Bill of Lading tistuits given to me by the truckers at the time of loading (copies enclosed). Tonya would wrally text or call with the bwhels and moisture which I then wrote on the BOL's.

I assumed I would be getting paid after the last load was howled, but H+I was often slow about paying. Various times I had called the girls in the office and got responses such as Tami being gone, checks won't go out till the next Friday, check should be in the mail, etc. Between these type of stall tactics and me getting really busy with spring planting, it got put on the back burner" and I never got paid.
