NOTICE OF NEED TO FILE A PROOF OF CLAIM

The trustee has recovered assets in this bankruptcy case. If you wish to share in any distribution of funds, you must file a proof of claim with the Bankruptcy Clerk. To be considered timely, your proof of claim must be received by the Bankruptcy Clerk **on or before May 19, 2025**. Generally, if you file a proof of claim after this date, you will not share in any distribution of funds. There is no fee for filing a proof of claim.

In this district, you may file a proof of claim in one of two ways:

1. You or your attorney may file a proof of claim through the **Electronic Proof of Claim** ("ePOC") program. ePOC may be accessed through the Court's website at www.sdb.uscourts.gov under the "Claims" tab. Pre-registration or special training is not required to use ePOC.

OR

2. You may complete, sign, and file a proof of claim using **Official Form 410**. You may find the official form on the Court's website at www.sdb.uscourts.gov under the "Claims" tab. You may also request an official form by calling the Bankruptcy Clerk's office in Sioux Falls at (605) 357-2400 or in Pierre at (605) 945-4460. You must **fully complete** the official form, **attach any necessary documents** to it, and **sign it**. Do **not** leave the signature line blank; do not type or stamp your signature. You must mail or deliver the completed and signed official form to the address below. If you mail it, do so sufficiently before the deadline so the Bankruptcy Clerk receives it on or before the deadline.

If you are an attorney, you must electronically file the completed and signed official form using the Court's Case Management/Electronic Case Files system ("CM/ECF"). If you are a "limited filing user," you also may file the completed and signed official form using CM/ECF. To become a limited filing user, you must obtain a Public Access to Court Electronic Records ("PACER") account and register with the Court.

If you have already filed a proof of claim in this case, you do not need to file another. More information about claims, including how to amend, supplement, transfer, or withdraw a claim, may be found on the Court's website under the "Claims" tab. Consult your attorney for assistance.
