We have come to the time of year for renewal of all South Dakota grain buyer and grain warehouse licenses. We would like to thank all of you for your cooperation during the challenging 2020 license renewal period. The South Dakota Public Utilities Commission Grain Warehouse Program is implementing a change to the license renewal notice process. This year we are emailing the renewal information instead of postal service mailing as in years past. If you prefer to receive the paper copy of the license renewal information you may reply to this email or reach us at the phone number below.

Attached is a letter from our Grain Warehouse Program Manager, Cody Chambliss. Also attached is a check list to assist you with the renewal process.

The application can be found on the SD PUC website (www.PUC.SD.gov/warehouse), see the link below. The application needs to be printed and signed by owner, managing partner or chief executive officer of the applicant, and shall be notarized.
