On January 3, 2022, Dallas Langley Trucking sent an email to the South Dakota Public Utilities Commission Staff (staff), challenging the denial of Dallas Langley Trucking's Application for a Grain Buyer License. Upon receipt of this email, staff opened a docket to provide for the South Dakota Public Utilities Commission (Commission) to review the denial of the Application for a Grain Buyer License along with an opportunity for a hearing on the matter.

On January 6, 2022, the Commission electronically transmitted notice of the filing to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. On January 18, 2022, the Commission received an email from Dallas Langley Trucking to withdraw the request for a Commission hearing. On January 19, 2022, staff filed a letter confirming that Dallas Langley Trucking was withdrawing the request for Commission review of staff's denial of the Application for a Grain Buyer License and further requested that the docket be dismissed and closed.

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-45 and ARSD 20:10:01:02.04.

At its regularly scheduled meeting of February 1, 2022, the Commission considered this matter. Mr. Langley joined by phone and answered a number of Commissioner questions. Staff recommended that the Commission grant Dallas Langley Trucking's request to withdraw his request for a hearing and to dismiss and close the docket. Mr. Langley did not object. The Commission voted unanimously to grant the request to withdraw the request for a hearing and to dismiss the docket and close it. It is therefore

ORDERED, that Dallas Langley Trucking's request to withdraw its request for a hearing is hereby granted. It is further

ORDERED, that the docket is dismissed and closed.
