**AFFIDAVIT OF
BROCK TAYLOR**

1. I am employed by TC Energy as Land Manager. I have overseen the release or termination of county and township haul road agreements in South Dakota related to the Keystone XL Pipeline project. I have also been involved in the process of closing the work camp sites in South Dakota where construction began. I have personal knowledge of the facts stated in this affidavit.

3. Attached as Exhibit B is a release of the Scovil Township Haul Route Agreement signed by Raymond Roghair as Chair of the Scovil Township.

4. I supervise a land agent, John Ohlms, who at my direction contacted townships in Jones County that had entered into haul road agreements for the Keystone XL Pipeline project. He produced written confirmation of his conversations with Sam Seymour of Buffalo Township, Bob Fuoss of Draper Township, Ross Block of South Creek Township, and Kenny Booth of

Williams Creek Township, in which each township supervisor agreed that the township was aware of no outstanding repair issues covered by the haul road agreement for the Keystone XL Pipeline project, and that the haul road agreement could be terminated.

5. The six townships identified in paragraphs 2-4, all of which are in Jones County, are the only townships in South Dakota that signed haul road agreements for the Keystone XL Pipeline project. Thus, I have confirmed that there are no outstanding road issues with any South Dakota township related to the Keystone XL Pipeline project.

6. Keystone leased real property in South Dakota for the construction of four work camps to support construction of the Keystone XL Pipeline. In anticipation of construction of the pipeline, Keystone started work at two of the four work camps, one at Opal and one at Philip, South Dakota. In 2021, TransCanada Keystone Pipeline, LP, released and terminated the leases for the two undeveloped camps and reached agreement with the landowners of the Opal and Philip camps that the leases were terminated and the landowners accepted the property in its “as is” condition.
