Honorable Judges, esteemed Commissioners, and carbon lawyers:

Spink County. Carbon Summit's team has informed us from the beginning that, no matter what we say, it has the right to survey and examine our properties which are along its anticipated route.

Please note that my sister Beverly Felderman nor I Marilynne Felderman have never disputed that. What we have said, in writing or orally, is that we do not intend to give Summit permission for such access. We object to such use. We reject the offer of money for easement.

To the contrary, we owners of this half section expected Summit to use its legal powers and to be on the land toward the end of July. Please see our letter, attached, of July 8, 2022 to our renters and nearby neighbors notifying them of the arrival of Summit's surveyors and that no one should impede legal and legitimate Summit activities. We have been assuming Summit Carbon accomplished this action months ago.

Please be aware that, although we have been showered with Summit's papers, calls, texts, and now County Sheriff summons, Summit has never given us paperwork allowing us to declare our understanding of its access rights in surveying and examining our property.

In fact, today's summons documents still provide no means for accepting or rejecting or otherwise showing that we have no intention of "interfering with Summit's right." May Summit use its legal right to enter our land without our permission? Of course. That does not make the access palatable.

Dear Gary and Tom,

Carbon Solutions wants to use a tiny portion of our rural credit land (the NE corner) to gain its pipeline's access through your land.

Beverly and I have told Carbon Solutions we do not agree to let them enter our property for their survey work. They so far have not sent us any document to approve or disapprove their entry. The denial was via phone.

However, earlier on, we did sign the first documents sent by Carbon Solutions' SD attorneys <u>declining</u> to accept the easement offer. We have written the SD Public Utility Commission, asking its <u>rejection</u> of Carbon Solutions' proposal. We have no intention of changing our minds on this issue.

We do understand that the surveying contractors of Carbon Solutions have a legal right to enter our property to survey. And that the surveyors are/were anticipating July 20 or later for such activity.

Beverly and I do not expect you, as renters and neighbors to our land, to question, stop, prevent in any way the lawful surveying of our land. However, per our land rental agreement, should you see any degradation to the land proper or to your crops, please let us know immediately so that we can raise an appropriate objection with Carbon Solutions.
