We the undersigned members of the Hand County Board of Commissioners believe that the use of eminent domain condemnation proceedings by the carbon capture pipeline companies is unconstitutional. The original and limited justifications for the application of and resort to eminent domain were and remain the advancement and facilitation of necessary public infrastructure.
