Natural Gas Distribution Rate Increase Black Hills

On December 21, 2012, Montana Dakota Utilities, Co. (Montana-Dakota) filed an application for authority to increase rates for natural gas service to customers in its South Dakota Service Territory with the Public Utilities Commission (Commission). The Company proposed an increase of approximately \$1.5 million annually or 3.3 percent of total retail revenues, based on Montana-Dakota's test year ending June 30, 2012. In its application, Montana-Dakota also requested that the Black Hills and East River service areas be consolidated into one rate jurisdiction. The rate increase is driven primarily by the need to recover investments made in infrastructure and technology improvements.

On October 31, 2013 the Commission authorized an increase in revenues of \$898,778 or approximately 2 percent annually. As allowed by South Dakota Codified Law 49-34A-17, Montana-Dakota implemented Interim Rates effective July 22, 2013 as a percentage of bill based on the total revenues requested. The difference between the final rates and the interim rates will be refunded to customers with interest.

A typical residential customer in the Black Hills area using 75 dk on an annual basis will see an average increase of approximately \$2.00 per month.
