(MDU), and Ring-Neck Energy & Feed, LLC, dba Ring-Neck Energy, LLC (Rink-neck) jointly referred to as “Parties,” hereby file this Joint Motion for Approval of Amendment to Settlement Stipulation (Amendment). The Parties request that the South Dakota Public Utilities Commission adopt the attached Amendment as the settlement and resolution of all the issues between the Parties in this proceeding arising from SDIP’s September 24, 2019 Letter regarding Rate Adjustment and approve the associated tariff pages.

In support of this Motion, the Parties submit as follows:

2. The Amendment resolves all issues between Staff and Applicant in this docket arising from SDIP’s September 24, 2019 Letter regarding Rate Adjustment;
3. The terms of the Amendment represent a negotiated settlement of all the issues between the Parties in this docket arising from SDIP’s September 24, 2019 Letter regarding Rate Adjustment;
4. The terms of the Amendment agreed upon are just and reasonable and consistent with South Dakota Law.
