PETITION FOR INTERVENTION BY RING-NECK ENERGY & FEED, LLC

Pursuant to ARSD Sec. 20:10:01:15.02, Ring-Neck Energy & Feed, LLC, dba Ring-Neck Energy, LLC ("Ring-Neck), petitions to intervene in the above captioned proceeding. In its Petition filed on December 3, 2019, South Dakota Intrastate Pipeline Company ("SDIP"), requests that it be granted a waiver for its loss and unaccounted adjustment percentage ("L&U") filing for 2020, or in the alternative, for the determination of its L&U.

On or about April 2019, Ring-Neck began receiving gas through the SDIP pipe. The appropriate L&U relating to the gas purchased by Ring-Neck through the SDIP pipeline needs to be determined or agreed to between the parties and the commission.

As a taker of gas through the SDIP pipe, the determination by the commission of the appropriate L&U percentage or waiver of a determination of that percentage directly impacts Ring-Neck and as such, it has a direct interest in the proceeding and that the interest is peculiar to Ring-Neck as opposed to the interest of the public or taxpayers in general.

WHEREFORE, Ring-Neck requests it is granted intervention status in this proceeding as the commission determines whether or not SDIP should be granted a waiver for its L&U filing in 2020, or in the alternative, if the commission should determine the appropriate L&U going forward.
