The Staff of the Public Utilities Commission (Staff) and South Dakota Intrastate Pipeline Company (SDIP), Montana-Dakota Utilities Co. (MDU), and Ring-Neck Energy & Feed, LLC, dba Ring-Neck Energy, LLC (Rink-neck) jointly referred to as “Parties,” hereby file this Joint Motion for Approval of Settlement Stipulation (Stipulation). The Parties request that the South Dakota Public Utilities Commission adopt the attached Stipulation as the settlement and resolution of all the issues between the Parties in this docket.

In support of this Motion, the Parties submit as follows:

1. This Joint Motion is made pursuant to ARSD 20:10:01:19;
2. The Stipulation resolves all issues between the Parties with respect to its 2020 Loss and Unaccounted Adjustment Percentage (L&U);
3. The terms of the Stipulation represent a negotiated settlement of all the issues between the Parties in this docket arising from SDIP’s December 3, 2019 request for waiver of its 2020 L&U filing;
4. The terms of the Stipulation agreed upon are just and reasonable and consistent with South Dakota Law.

WHEREFORE, for the foregoing reasons, the undersigned Parties jointly request the Commission grant the Joint Motion for Approval of Settlement Stipulation and adopt the attached Settlement Stipulation without modification for the purpose of resolving all issues between Parties arising from SDIP’s December 3, 2019 request for waiver of its 2020 L&U filing.
