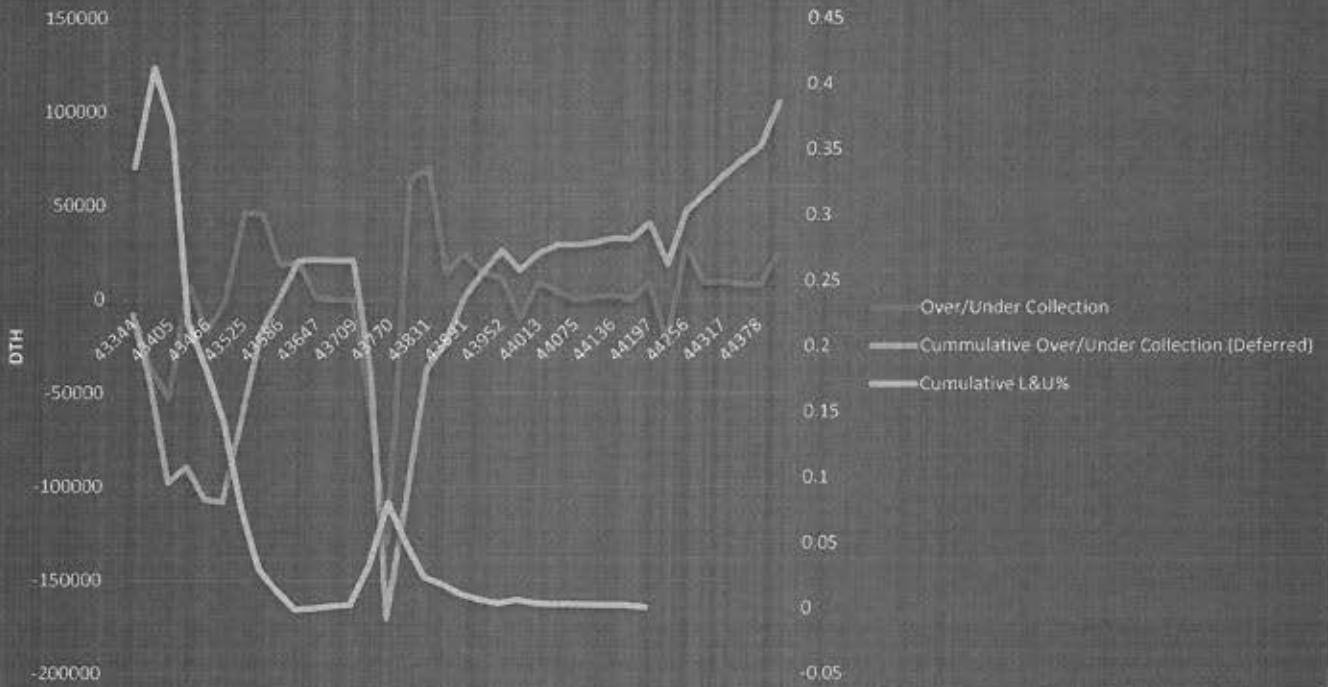
The South Dakota Intrastate Pipeline Company (“SDIP”) hereby makes and files this Loss and Unaccounted Percentage (“L&U”) Compliance Filing. Pursuant to the Settlement Stipulation previously executed by the parties in this docket on or about April 26, 2021, and the Order entered by the Commission on May 5, 2021, SDIP is to make a compliance filing in this docket on or before November 1. SDIP’s 2021 leak survey on its pipeline completed on October 19, 2021, determined that leaks do not exist on SDIP’s pipeline. Based upon the information provided by MDU, the L&U should remain at 0.14%. In support of this calculation, SDIP provides the summary calculation document attached hereto as Exhibit A. MDU presented to SDIP the following calculations for the period of September 2020 through August 2021:

Beginning Deferral Balance = 28,819.2 Dth
Total Receipts = 2,671,230.0 Dth
Total Deliveries = 2,743,653.5 Dth
Calculated Test Period L&U = -3.8343%¹
L&U Collected = 3,864.0 Dth

¹ This net gain is likely due to the turbine meter at MINA running slow which was discovered when the annual testing was conducted in May of 2021. There is no formula to determine the actual percentage that the meter is off. SDIP replaced the meter on 6-1-2021 with a new calibrated turbine meter. SDIP and MDU are in agreement that L&U in place currently is the correct number to use.
