- On or about April 2019, Ring-Neck began receiving gas through the South Dakota Interstate Pipeline Company ("SDIP");
- 2. Ring-Neck's receipt of gas is metered at a meter station in Onida, South Dakota;
- 3. According to the filing made by SDIP on October 19, 2020, SDIP's 2020 leak survey on its pipeline completed on September 30, 2020, showed that leaks did not exist on SDIP's pipeline;
- 4. This filing is made in regard to the request of SDIP to leave the L&U at .14%; and,
- 5. Ring-Neck requests the Commission set the L&U rate at 0.0% as it is the only customer, it believes, who has to pay the L&U and with no leaks existing it should not have to pay overages.
