ORDER APPROVING
CONTRACT WITH
DEVIATIONS
AND APPROVING
TARIFF REVISON

On August 20, 2021, the South Dakota Public Utilities Commission (Commission) received a filing from NorthWestern Corporation dba NorthWestern Energy (NorthWestern) for approval of a contract with deviations with Crystal Springs Feeds, LLC (Crystal Springs). Crystal Springs desires to have natural gas service extended to its location to serve its heating and grain processing requirements. NorthWestern will run a gas line approximately 1.3 miles to serve the new customer. NorthWestern states that based on the cost of the project, it requires security for the capital investment cost and a monthly surcharge in order to protect its legacy customers. The contract includes recovery of the pipeline project costs over a 15-year period. The project costs and tariff delivery charges will be recovered through a fixed monthly charge based on projected annual volumes, with an annual review conducted to determine if volumes exceed the projected amount. Any overages will be billed at the tariff rate 87B. NorthWestern requests approval with an effective date for the tariff revisions of October 1, 2021. NorthWestern also proposes to remove the listing of South Dakota Wheat Growers customers due to the completion of their contract obligations.

On August 26, 2021, the Commission electronically transmitted notice of the filing and the intervention deadline of September 10, 2021, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed.

The Commission has jurisdiction over this matter pursuant to SDCL 49-34A, specifically 49-34A-6, 49-34A-8, 49-38A-8.3, 49-34A-10, and 49-34A-11.

At its regular meeting on September 14, 2021, the Commission considered this matter. Commission staff recommended approval. Finding that NorthWestern's request for approval of a contract with deviations with Crystal Springs and the associated tariff sheet is just and reasonable, the Commission voted unanimously to grant NorthWestern's request for approval of a contract with deviations and to approve the associated tariff sheet with an effective date of October 1, 2021. It is therefore

ORDERED, that NorthWestern's request seeking approval of a contract with deviations with Crystal Springs is hereby granted with an effective date of October 1, 2021. It is further

ORDERED, that the revisions of the above-referenced tariff sheet to reflect the contract with deviations with Crystal Springs and the removal of South Dakota Wheat Growers is hereby approved, effective October 1, 2021.
