With this filing, MidAmerican is proposing a number of minor "housekeeping" changes to its gas tariff. The following is a page-by-page summary of these changes.

Section No. 1, Sheet No. 10 is being revised to update the sheet numbers for the Standard Residential Bill Form and removal of the sample forms in Section 6; Residential and Commercial Applications and Deferred Payment Agreement.

Section No. 2, Sheet Nos. 1 and 2 are being revised to update the information regarding the communities served by MidAmerican, including the addition of farm tap service locations .

Section No. 3, Sheet Nos. 2, 5, 10 and 15.3 are being revised to indicate Clause EECR – Energy Efficiency Cost Recovery Adjustment and Clause IE – Incremental Expansion Surcharge Adjustment are not always applicable. These revisions also indicate Rider PDR – Pipeline Demand Rider may apply as described on Section No. 3, Sheet Nos. 89 and 90.

Section No. 3, Sheet Nos. 9, 21, 27, 42, 44, 49, 56, 81 and 82 are being revised to provide consistency throughout MidAmerican's gas tariff by showing text as both numerical and alphabetical where necessary.

Section No. 3, Sheet Nos. 14 and 91 are being revised to correct typographical errors.

Section No. 3, Sheet Nos. 19 and 25 are being revised to indicate Clause IE – Incremental Expansion Surcharge Adjustment is not always applicable.

Section No. 3, Sheet Nos. 29 and 32 are being revised to replace Clause PGA – Cost of Purchased Gas Adjustment with Rider S – System Gas Service under the list of Adjustment Clauses and Riders. The statement of Rider S applicability necessitates the application of Clause PGA, making the inclusion of both on the list unnecessary.

Section No. 3, Sheet No. 47 is being revised to indicate Clause IE – Incremental Expansion Surcharge Adjustment is not always applicable and provide consistency throughout MidAmerican's gas tariff by showing text as both numerical and alphabetical where necessary.

Section No. 3, Sheet No. 68 is being revised to provide consistency throughout MidAmerican's gas tariff by including the applicable suffix (st) on dates where appropriate.

Section 3, Sheet No. 89 is being revised to clarify that Rider PDR – Pipeline Demand Rider only applies to daily-metered gas transportation customers, include the applicable suffix (st) on dates where appropriate and to provide consistency throughout MidAmerican's gas tariff by showing text as both numerical and alphabetical where necessary.

Section No. 5, Sheet Nos. 3, 19, 21 and 43 are being revised to provide consistency throughout MidAmerican's electric tariff by showing text as both numerical and alphabetical where necessary.

Section No. 5, Sheet No. 15 is being revised to reflect MidAmerican's recent customer office closures more accurately in the context of certain tariff provisions and correct a typographical error.

Section No. 5, Sheet Nos. 16 and 26 are being revised to correct typographical errors.

Section No. 5, Sheet No. 29 is being revised to reflect MidAmerican's recent customer office closures more accurately in the context of certain tariff provisions.

Section No. 5, Sheet No. 31 is being revised to update language under the "Agreements" heading to reflect current practice and procedures.

Section No. 5, Sheet No. 40 is being revised to include the applicable suffix (st) on dates where appropriate.

Section No. 5, Sheet No. 54 is being revised to clarify the charge for optional interval metering under the heading "METERING FACILITIES."

Section No. 6, Sheet Nos. 1, 2 and 2.1 are being revised to reflect the updated standard residential bill sample form.

Section No. 6, Sheet Nos. 3 and 4 are being revised to remove sample forms of the residential and commercial applications, respectively. These forms are outdated, and the service

application process can be conducted by electronically submitting an online request at https://www.midamericanenergy.com/start-stop-service or contacting MidAmerican at 888-427-5632.

Section No. 6, Sheet No. 5 is being revised to remove the sample form for establishing a deferred payment arrangement because this form is outdated, and such arrangements can be established by electronically submitting an online inquiry at https://www.midamericanenergy.com/feedback-form or contacting MidAmerican at 888-427-5632.

Section No. 6, Sheet Nos. 8 and 9 are being revised to reflect an updated copy of the customer release form.

MidAmerican submits this filing pursuant to South Dakota Administrative Rule 20:10:13:10 and respectfully requests an approval date of September 30, 2021.
