On August 23, 2021, the South Dakota Public Utilities Commission (Commission) received a filing from MidAmerican Energy Company (MidAmerican) requesting approval of tariff revisions. MidAmerican proposes a number of minor housekeeping changes to its natural gas tariff.

On August 26, 2021, the Commission electronically transmitted notice of the filing and the intervention deadline of September 10, 2021, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed. On September 9, 2021, MidAmerican filed revised tariff pages to make additional changes to its list and map of communities served. MidAmerican requests a September 30, 2021, effective date.

At its regularly scheduled meeting on September 28, 2021, the Commission considered this matter. Commission staff recommended approval of the tariff revisions, including the revisions filed on September 9, 2021, effective September 30, 2021. Finding the revisions to be just and reasonable, the Commission voted unanimously to approve the revisions, effective September 30, 2021. It is therefore

ORDERED, that MidAmerican's request to revise its aforementioned tariffs is hereby granted and the revisions are approved, effective for services rendered on and after September 30, 2021.
