On November 17, 2021, the South Dakota Public Utilities Commission (Commission) received a filing from NorthWestern Corporation dba NorthWestern Energy (NorthWestern) for approval of a contract with deviations with Brightmark Mill Valley RNG LLC (Brightmark). Brightmark desires to have NorthWestern install a natural gas pipeline that is approximately 3 miles in length. This pipeline will be used to transport renewable natural gas from the dairy farm it is being produced at, to an interconnection point roughly 1 mile south of Milbank, South Dakota. NorthWestern states that based on the cost of the project, it requires fixed monthly charge, take or pay volumes, and a security for the capital investment cost in order to protect its legacy customers. NorthWestern has also included natural gas quality standards Brightmark must achieve to have gas transported in the pipeline. The contract includes recovery of the pipeline project costs over a 15-year period and project costs will be recovered through a fixed monthly charge. An annual review will be conducted to determine if volumes have met the required take or pay amount. All volume charges will be billed at the tariff rate 87. On December 2, 2021, NorthWestern filed an Amended Agreement. NorthWestern requests an effective date of December 21, 2021.

On November 18, 2021, the Commission electronically transmitted notice of the filing and the intervention deadline of December 3, 2021, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listsery. No petitions to intervene or comments were filed.

The Commission has jurisdiction in this matter pursuant to SDCL Chapter 49-34A, specifically 49-34A-6, 49-34A-8, 49-34A-10, and 49-34A-11.

At its regular meeting on December 21, 2021, the Commission considered this matter. Commission staff recommended approval. Finding that NorthWestern's request for approval of a contract with deviations with Brightmark Mill Valley RNG, LLC and the associated tariff sheet is just and reasonable, the Commission voted unanimously to grant NorthWestern's request for approval of a contract with deviations and to approve the associated tariff sheet with an effective date of December 21, 2021. It is therefore

ORDERED, that NorthWestern's request seeking approval of a contract with deviations with Brightmark Mill Valley RNG, LLC is hereby granted with an effective date of December 21, 2021. It is further

ORDERED, that the revisions of the above-referenced tariff sheet to reflect the contract with deviations with Brightmark Mill Valley RNG, LLC is approved, effective December 21, 2021.
