The Commission has jurisdiction in this matter pursuant to SDCL Chapters 1-26 and 49-34A, specifically, 1-26-20, 49-34A-3, 49-34A-6, 49-34A-8, 49-34A-8.4, 49-34A-10, 49-34A-11, 49-34A-12, 49-34A-13, 49-34A-13.1, 49-34A-14, 49-34A-17, 49-34A-19, 49-34A-19.1, 49 34A 19.2, 49-34A-21, and 49-34A-22.

At its regularly scheduled meeting of March 28, 2023, the Commission considered this matter. The Commission heard from MidAmerican and the Commission Staff concerning the Joint Motion and Settlement Stipulation. Having thoroughly reviewed the filings in the docket and after having made further extensive inquiry of the parties, the Commission found that the terms and conditions proposed in the Settlement Stipulation were just, reasonable, and in the public interest and that good and sufficient cause was demonstrated to approve the Settlement Stipulation. The Commission voted unanimously to grant the Joint Motion and approve the Settlement Stipulation. The Commission also considered the issue of approving MidAmerican's Interim Refund Plan. Finding that the plan proposed by MidAmerican properly balances the interests of MidAmerican in having a workable plan that is not unduly administratively burdensome and the interests of customers in obtaining a prompt and substantially complete refund of non *de minimis* over-collections during the interim period and is therefore just and reasonable, the Commission voted unanimously to approve MidAmerican's Interim Refund Plan contingent on a MidAmerican compliance filing to address requested changes to its customer notices. It is therefore

ORDERED, that the parties' Joint Motion for Approval of Settlement Stipulation is hereby granted. It is further

ORDERED, that the Settlement Stipulation is hereby approved. The Settlement Stipulation is incorporated by reference into this order the same as if it had been set forth in its entirety herein. It is further

ORDERED, that MidAmerican's Interim Refund Plan is approved as filed, contingent on a MidAmerican compliance filing to address requested changes to its customer notices. It is further

ORDERED, that the tariff sheets set forth above are approved for service rendered on and after April 1, 2023.
