On January 20, 2023, the South Dakota Public Utilities Commission (Commission) received a filing from NorthWestern Corporation dba NorthWestern Energy (NorthWestern) for approval of a contract with deviations with Brookings Biogas, LLC (Customer). The Customer intends to deliver renewable natural gas (RNG) produced to NorthWestern for the purpose of transportation. RNG will be transported via a customer-owned and operated pipeline from two dairy facilities. The Agreement includes provisions to secure project costs and guaranteed delivery volumes to support the project recovery over a 15-year period. NorthWestern proposes an effective date of March 1, 2023.

On January 26, 2023, the Commission electronically transmitted notice of the filing and the intervention deadline of February 10, 2023, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed.

The Commission has jurisdiction in this matter pursuant to SDCL Chapter 49-34A, specifically 49-34A-6, 49-34A-8, 49-34A-8.3, 49-34A-10, and 49-34A-11.

At its regular meeting on February 28, 2023, the Commission considered this matter. Commission staff recommended approval. Finding that NorthWestern's request for approval of a contract with deviations with Customer and the associated tariff sheet is just and reasonable, the Commission voted unanimously to grant NorthWestern's request for approval of a contract with deviations and to approve the associated tariff sheet with an effective date of March 1, 2023. It is therefore

ORDERED, that NorthWestern's request seeking approval of a contract with deviations with Customer is hereby granted with an effective date of March 1, 2023. It is further

ORDERED, that the revisions of the above-referenced tariff sheet to reflect the contract with deviations with Customer is hereby approved effective March 1, 2023.
