ORDER GRANTING JOINT MOTION FOR APPROVAL OF SETTLEMENT STIPULATION AND ADOPTING SETTLEMENT STIPULATION

NG24-005

On June 21, 2024, the South Dakota Public Utilities Commission (Commission) received an application from NorthWestern Energy Public Service Corporation dba NorthWestern Energy (NorthWestern) for approval to increase rates for natural gas service to customers in its South Dakota service area by approximately \$6.0 million annually or approximately 9.10% based on NorthWestern's 2023 historic test year. NorthWestern states a typical residential customer using 100 therms of gas per month would see an increase of \$8.38 or 7.92% per month. The proposed changes may affect approximately 49,800 customers.

On June 27, 2024, the Commission electronically transmitted notice of the filing and the intervention deadline of August 19, 2024, to interested individuals and entities on the Commission's PUC Weekly Filing electronic listsery. No petitions to intervene or comments were filed. On July 8, 2024, the Commission issued an Order Assessing Filing Fee; Order Suspending Operation of Proposed Rates; Order Authorizing Executive Director to Enter into Consulting Contracts. On December 4, 2024, NorthWestern and staff filed a Joint Motion for Approval of Settlement Stipulation and a Settlement Stipulation, and staff filed a Staff Memorandum Supporting Settlement Stipulation. On December 16, 2024, Commissioner Fiegen filed a Letter Regarding Customer Notice. On December 17, 2024, NorthWestern filed a revised Bill Insert Notice.

The revised tariff sheets proposed by NorthWestern and filed as Exhibit 2 to the Settlement Stipulation. effective for service rendered on and after December 19, 2024, are as follows:

The Commission has jurisdiction in this matter pursuant to SDCL Chapters 1-26 and 49-34A, specifically, 1-26-20, 49-34A-3, 49-34A-6, 49-34A-8, 49-34A-8, 49-34A-10, 49-34A-11, 49-34A-12, 49-34A-13, 49-34A-13, 49-34A-14, 49-34A-17, 49-34A-19, 49-34A-19.1, 49 34A 19.2, 49-34A-21, and 49-34A-22.

At its regularly scheduled meeting on December 17, 2024, the Commission considered the Joint Motion for Approval of Settlement Stipulation. The Commission heard from NorthWestern and Commission staff concerning the Joint Motion and the related Settlement Stipulation. Having thoroughly reviewed the filings in the docket and made further inquiry of the parties, the Commission found that the terms and conditions proposed in the Settlement Stipulation were just, reasonable, and in the public interest and that good and sufficient cause was demonstrated to approve the Settlement Stipulation. The Commission voted unanimously to grant the Joint Motion and adopt the Settlement Stipulation with the revisions to the proposed Customer Notice as filed on December 17, 2024. It is therefore

ORDERED, that the Joint Motion for Approval of Settlement Stipulation is hereby granted and the Settlement Stipulation is hereby adopted. The Settlement Stipulation is incorporated by reference into this order the same as if it had been set forth in its entirety herein. It is further

ORDERED, that NorthWestern's proposed Customer Notice is approved as revised on December 17, 2024. It is further

ORDERED, that the tariff sheets set forth above are approved for service rendered on and after December 19, 2024.
