On June 28, 2024, the South Dakota Public Utilities Commission (Commission) received a filing from Montana-Dakota Utilities Co., a Subsidiary of MDU Resources Group Inc. (MDU), for approval to discontinue the North Deadwood Expansion Area Surcharge Rate 75. MDU states in the filing the development where Rate 75 is applicable has encountered issues hindering its ability to move forward that will not be resolved in the foreseeable future. MDU will refund customers dollars collected through the Rate 75 tariff within 90 days of a Commission Order discontinuing Rate 75 and submit a compliance filing to the Commission summarizing the refund.

On July 3, 2024, the Commission electronically transmitted notice of the filing and the intervention deadline of July 18, 2024, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed.

The Commission has jurisdiction in this matter pursuant to SDCL Chapter 49-34A, specifically 49-34A-4, 49-34A-6, 49-34A-8, 49-34A-8.3, 49-34A-10, 49-34A-11, and ARSD Chapter 20:10:13.

At its regular meeting on July 19, 2024, the Commission considered this matter. Commission staff recommended approval. Finding MDU's request to be just and reasonable, the Commission voted unanimously to discontinue the North Deadwood Expansion Area Surcharge Rate 75 and approve associated tariff revisions as filed on June 28, 2024. It is therefore

ORDERED, that MDU is hereby authorized to discontinue the North Deadwood Expansion Area Surcharge Rate 75. It is further

ORDERED, that the above-referenced tariff sheets are approved, effective August 1, 2024.
